Q: Can you clarify what "SHSPP" stands for?

A: SHSPP stands for Supporting Healthy Start Performance Project. That is the title of the HRSA/MCHB cooperative agreement to fund a Healthy Start technical assistance center.

Q: How do we find out who our project officer is?

Q: What does the acronym "COIN" stand for?

A: COIN stands for Collaborative Innovation Network. COINs have been described as cyberteams of self-motivated people with a collective vision, that are enabled by technology and innovatively collaborate by sharing ideas, information, and work. Q: Have performance measures for the Maternal Mortality grant been established? What will be the reporting requirements for this grant?

A: There are no performance measures at this time and more information will be shared in the next few months on how we may track these activities and assess outcomes, as well as opportunities for technical assistance.

A: Thank you for expressing interest in continuing this specific tool. We are looking forward to hearing from each Healthy Start program over the next couple of months about what support is most valuable from the TA Center as part of our needs assessment. This will directly inform our approach to best meet your needs over the next five years, which will involve different activities than the previous TA Center.
